County Councillor – Cllr Middleton

The Clerk advised that she had received anything from Cllr Middleton.

Borough Councillors –

Cllr de Whalley advised that at a recent Regeneration and Development Panel the Town Investment Plan Vision was discussed. This involved walk/cycling infrastructure Plan to include the Town Centre, the Wootton's, Pott Row & Grimston. The aim is to make the B1145 safer to walk/cycle along. Cllr de Whalley asked people to look at www.visionkingslynn.co.uk. It also involves a School of Nursing starting up at the College. There is a consultation which he encouraged people to take part in but this needed to be achieved urgently as the deadline is this Sunday 11 October 2020.

Cllr de Whalley then went on to say that the CIL grant funding was on track and should be released in the next couple of months with a three month window to apply. The grants of £10,000 or under had to be in one of four categories. Community Facilities, Green Infrastructure, Open Space and Leisure & Community Transport. Match funding will be favoured.

Cllr de Whalley advised that he was currently trying to get Gaywood Valley registered as an area of Natural Beauty with the Norfolk Coast Partnership. The Closing date had expired but felt that if people still wanted to ask for it to be included it might not be too late.

Cllr de Whalley advised that he was hoping to be able to give the Council the Borough Council's take on the Planning White Paper but was still waiting for the Borough Council to advise Councillors properly. The details are that it has three elements,

Cllr Currey thanked Cllr de Whalley for his report.

Cllr Manning advised that he was going to say pretty much the same things as Cllr de Whalley. He was hoping that as he sits on the Planning Committee they would get extra presentations with regard to the Planning White paper bit this has not been the case.

Cllr Manning advised that he had missed the White Paper talk as he was asked and attended the Police and Crime Commissioners update. Cllr Manning advised that there was a briefing for three quarters of an hour with Councillors etc prior to the main talk. The meeting was advised that the future of Policing involved hopefully getting a good number of the new 20,000 new Officers promised by Government. Cllr Manning also advised that the Old Hethersett School has now been turned into a Police Training School and he hoped to visit as soon as the Covid situation allowed.

Cllr Manning asked if any one had visited the new cinema at the Corn Exchange which was up and running and opened on the 25 September.

There are two Borough Council meeting coming up on this Thursday 8th which is a Special Full Council meeting followed the week after on the 15th which is an ordinary Full Council meeting both starting at 4:30 at 3:00 was too early for working Councillors. Cllr Beales asked if members of the public were able to ask questions during these meetings. Cllr Manning advised yes but might be better to inform of the question/s prior to the meeting just in case the technology fails.

Cllr Currey thanked Cllr Manning for his report.

- 10.1 To receive update and consider any action on NCC Ranger Works. Cllr Dewing advised that there was currently some Anti-Social Behaviour around parking in Vicarage Lane and was churning up the grass verge which was at a stage of the verge collapsing. Cllr Dewing was wondering if some bollard could be put in place.
